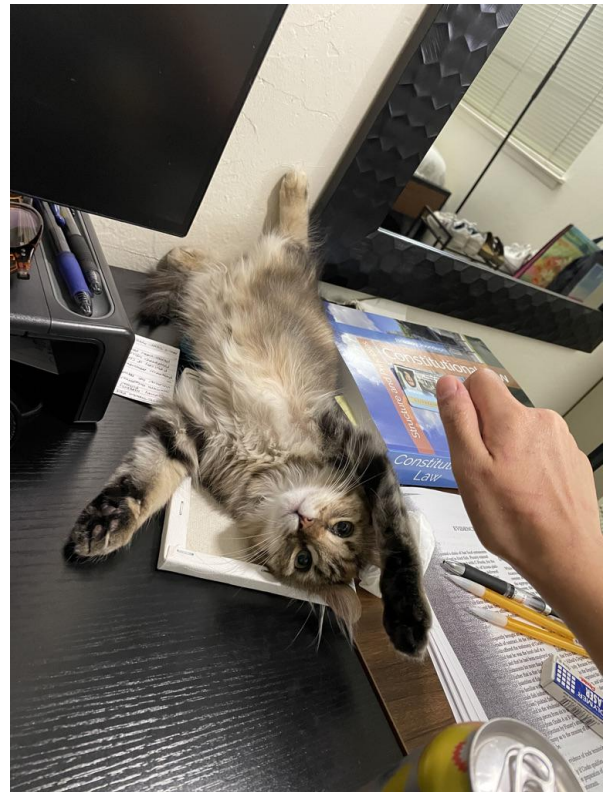
It's week 12! We hope you had a safe and fun Halloween weekend. Personally, we are exhausted.
