- [Millions in U.S. lose jobless benefits as federal aid expires, thrusting families and economy onto uncertain path](#): Federal funds meant to ease the economic shock of the pandemic are coming to an end. 'It just feels like being discarded,' one worker said
- [Abortion Clinics Are Already Seeing a Wave of Patients Fleeing Texas](#): Clinics in the states surrounding Texas are scrambling to keep up with a surge of people desperate for abortions.
- [Justice Dept. says it will protect women seeking abortion in Texas](#): Attorney General Merrick Garland said the department is exploring options to challenge the Texas law, one of the most restrictive in the nation.
